Father Invites You to Join

Parish priests are our spiritual leaders, and the Knights of Columbus seeks to support and share a close relationship with them. As part of your council's recruitment strategy, meet with your pastor about the possibility of conducting a "Father Invites You to Join" membership campaign in your parish.

Here are some steps to follow:

First, speak to your pastors about the "Father Invites You to Join" campaign. Explain that the campaign would begin by sending an invitation in his name to prospective members. Let him know that the letter would, of course, include any input he would like to provide. Or, if he is under time constraints, it can follow the format of the invitation found under the "For Members" section of kofc.org.

Second, ask your pastor for a parish membership roster. Using this, a team of five or six Knights — all of whom should be very active members of your parish — should review the roster and highlight any men they would recommend for membership.

Third, using the team's selections, make a list of prospects. Include each prospect's name, address, phone number, email and wife's name, if applicable. Take the prospect list to your priest and ask him to review it and validate each prospect as a practical Catholic. Also, ask him if there are any parishioners he would like to add to the list.

Fourth, schedule an open house. Make sure your pastor, recruitment team, council officers, field agent and several other council members are able to attend on that date.

Fifth, send the prospects a "Father Invites You to Join" letter and an invitation to your open house. In a few days, follow up with a phone call to encourage the prospect to attend.

Finally, conduct the open house. Ask your pastor to invite each prospect to join the Order. Have recruitment team members ready with *Membership Documents* (#100) and pens to assist prospects in signing up or to answer their questions. End the event with a prayer and information on when the next First Degree Exemplification will take place.

The best solution I've seen has been a large square foam cooler that's about 24"X20"X16" with 2 or 3 small YETI ice packs. The top is easily removed and it's a fairly inexpensive way to go.

If you could include a touch more detail to your order specifics that would help immensely. Be sure to include your name, phone, email, and physical address as the form instructs.

NEW AWARD ANNOUNCED

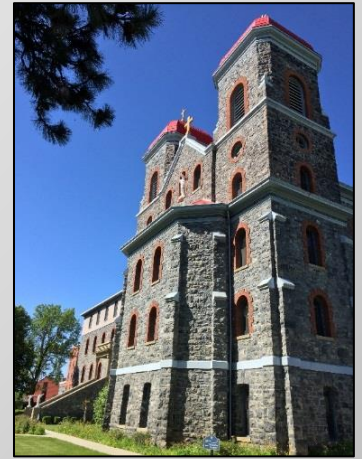

The completed SP-7 must be presented to State Secretary Shane Gehring when the delegates turn in their credentials prior to the start of the convention.

To Be or Not to Be is the Question ... A 4th Degree Sir Knight?

Every Knights of Columbus Council should be comprised of all Fourth Degree Knights. The progression through the four degrees should be a seamless process with each Knight receiving words of encouraging support from both council and assembly brothers. The lessons taught in the Fourth Degree ceremony completes the full body of knowledge and appreciation of our order.

Not becoming a Fourth Degree is equivalent to going to high school and not becoming a “senior”. Some brothers fear that becoming a Fourth Degree Knight incurs a significant increase in required volunteerism (time). This is not true. The Knights of Columbus has always only asked for its brethren to only give what time they can comfortably afford. Quality time with your spouse and family should be your top priority.

Once a Knight becomes a Fourth Degree Knight, an opportunity exists to join the Color Corp and participate in a number of critically important church related activities such as vigils, funeral masses, Bishop’s Mass, and special ceremonies throughout the Treasure Valley, and areas all around the state, e.g. Idaho State Convention Memorial Mass. The recognition and praise one receives as a Color Corp member is so gratifying and rewarding. For example, it is not uncommon to hear at a vigil or funeral mass: “here come the Knights”! What a long lasting, positive impression (imagine) you engender in those parishioners and guests who are so sincerely grateful for your presence and ceremonial participation. In addition, there is a personal intrinsic rewarding feeling being so blessed and privileged to be an instrument of God’s goodness to our parish, congregation, and community.



In closing, the Knights of Columbus serves as the “strong right arm of the church”. The Fourth Degree advancement completes a brother Knight’s comprehensive maturation progression in the Order. Once a Sir Knight, the opportunity to become a Color Corp member avails itself. It is said the Color Corp is the most “visible and recognizable” element of Knights of Columbus.

So please seriously consider your advancement to the Fourth Degree and possible involvement with the Color Corp. It is NOT a requirement to join the Color Corp, merely an opportunity.

Building the Domestic Church



Brother Knights with the end of this fraternal year just three months away Supreme has created a new opportunity for your council to receive credit for a “domestic church” activity. If your council is providing meatless meals on Fridays during Lent in partnership with the parish’s stations of the cross, Supreme has a new program called “Simple Supper and Stations” which you can use as one of your four “domestic church” activities to earn the Columbian Award. Councils doing this should list “Simple Supper & Stations” as a Church program and domestic church activity on their Columbian Award Application (SP-7).

By the time this newsletter is published Easter will be about 15 days away.

Appropriately, the April theme in the *Family Fully Alive* booklet is “Mercy and Forgiveness”. The theme speaks directly to the sacrament of reconciliation and the recommended family project is: “As a family, go to church for the sacrament of reconciliation. A week later, take a few moments to discuss how the sacrament has helped each of you to be more holy and to fight against temptation and sin”. The theme, the meditation, and the family project reflect St. Pope John Paul II’s statement in *Familiaris Concortio* over twenty years ago, “The celebration of this sacrament (*reconciliation*) acquires special significance for family life. While they discover in faith that sin contradicts not only the covenant with God, but also the covenant between husband and wife and the communion of the family, the married couple and the other members of the family are led to an encounter with God, who is “rich in mercy,” who bestows on them His love which is more powerful than sin, and who reconstructs and brings to perfection the marriage covenant and the family communion.” The Pope also stated in the same Exhortation the following: “The future of humanity passes by way of the family”. These are great words of wisdom for Knights building the “domestic church” and strengthening our parishes.

Seriously consider reading the April theme, reflections, meditations, scripture verse, and do the family project in the *Family Fully Alive* booklet in preparation of holy week and Easter Sunday. If you do not have a copy yet you can read it on line at

Why Idaho Prolife Movement Supports H250 Repeal of Telehealth/Web Cam Abortion Ban



Friends:

There appears to be some confusion as to why the entire prolife movement in Idaho is supporting H250, which REPEALS the prolife Telehealth/Web Cam Abortion Ban Law passed in 2015.

Especially since this telehealth abortion method has proven to be extremely dangerous to women--at times causing hemorrhage, infection and even death.

Here is a brief explanation of why we support the repeal of this law!

In 2015, the Idaho prolife movement worked very hard to pass the remote-controlled chemical abortion ban or Web Cam Ban. It passed by a large majority in both the Idaho House and Senate, was signed into law by our Governor, and then went into effect in July of 2015.

A few months later, Planned Parenthood challenged the Web Cam Ban. They had originally indicated that they would NOT challenge this law.

To settle the case, the Idaho Attorney General's office entered into an agreement with Planned Parenthood.

Subsequently, Planned Parenthood has proceeded to begin performing web cam abortions in Twin Falls. Yes, the Twin Falls Planned Parenthood clinic is doing this, even though Planned Parenthood had originally testified in committee that they had NO plans of performing telehealth or web cam abortions in Idaho.

This year the prolife movement had a hard choice to make as a result of the agreement between the AG and Planned Parenthood. We were told that either the Legislature had to repeal this protective prolife law and/or if the Legislature chose not to repeal it, then the court would declare said law unconstitutional. Not much of a choice!

But after reflection, we felt it better for the Legislature to repeal the law rather than have the court set the dangerous precedent that this is an unconstitutional law.

We believe that the course of action we took will allow us to come back in the future when the judicial climate is better and again ask our prolife Legislature to re-enact the Web Cam Ban law.

This is a simple explanation, but I hope you get the point. The prolife movement had a very sad and difficult task. The prolife movement was forced to support repealing a very good, protective prolife law in order to stop the court from doing any further damage.

But we all strongly believe that sometime in the near future we will again prevail in banning web cam or telehealth abortions, which have proven to be so dangerous to women.

Please continue praying for us and all those mothers and babies affected by the repeal of this good and protective law.

Brothers and Sir Knights,

Many of you have heard me speak in the past about the reasons to progress through the degrees of the Order, and I ABSOLUTELY hate it when I hear a fellow Knight declare: "you can become an officer if you are a Third Degree Knight". For some highly motivated members, this may be true, but for many, this is a reason NOT to attain a higher degree. These members have no aspirations to become an officer and use this as an excuse to remain First or Second Degree members. Unfortunately, they miss a great opportunity to serve their brothers and learn leadership skills. The simple truth is that each degree imparts an important lesson about what it truly means to be a Knight of Columbus. Until you have reached the Fourth Degree, you have not fully learned what the Knights have to teach and share about living a Christian and Catholic life. It is also a statistical fact that those who reach the Fourth Degree are much more likely to remain in the Knights and be active in their councils and assemblies.

However, even in the higher degrees, a member is not required to hold an office if that is not their desire. Every council has many valuable members who have no desire to be an officer, but are always volunteering to help with projects. We all need these members to make a successful organization, but let's encourage them to learn all the lessons of the Order.

As a reminder: the next Fourth Degree Exemplification for those wishing to become Sir Knights will be held on Saturday, April 29, in Pocatello. Details were emailed to all Faithful Navigators, Comptrollers, Grand Knights, and Financial Secretaries of record. A Form 4 must be completed with all 5 signatures being required on the form. Form 4's need to be filled out completely and emailed to Comptroller Dave Molitor as soon as possible (dmgolfguy5@yahoo.com, or call 208-240-5935). The host assembly needs a count of guests and observers attending for dinner planning. We hope to see a good turnout for this fourth and final lesson in what it means to be a Knight of Columbus.

It is an honor to be included among such quality and caring men as our state leaders.

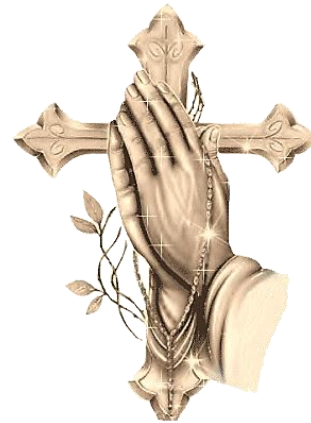

Over the course of the weekend, attendees at the Masses donated over \$15,500 toward the purchase of wheelchairs for children in need in Guadalajara, Jalisco, Mexico. The State Council congratulates Pope John Paul II Council and offers our sincere gratitude to the council and Father Vogel for their efforts. The generous gifts of the parishioners will lead the way for the purchase of wheelchairs for the children.

For those of you who may not know, Jalisco is a "Sister State" of Idaho. Yes, Virginia, the KofC RSVP Supports Men and Women Religious Too!

(even if they aren't going to be Priests!)

Many of your councils are doing a fantastic job of supporting our Diocesan seminarians. I hope that you have availed yourselves of the **\$500 RSVP/\$100 Rebate** from Supreme. What I would like to make you aware of is that we have men and women eligible for RSVP funds that are not attached to our Diocese of Boise! Even if they aren't called to be Priests, they have entered, and in formation, for, what is called, the "Consecrated Life".

Many times we tend to overlook those called to the "Religious or Consecrated Life". By this, I mean the Order priests, brothers, and sisters. Though we often don't realize it, they actually outnumber the parish priests! There is a virtual alphabet soup of Consecrated men and women that pray for you and I daily, offering time and talent, sacrificing their lives for our Holy Mother Church! From CSC, FSE, SNJM, RSM, CSJ, OSU, ST, OP, OSB, SJ, (Benedictine, Dominican, Franciscan, Ursuline, Holy Cross, Jesuits) to only name a very few that are in Idaho and Oregon!

Often secluded in monasteries, convents and religious houses, these are the men and women of different and beautiful charisms called to prayer (for us), silent witness, retreats, schools and many other ministries. All of which, from the priestly formation of our Diocese to formation of postulants, novices and seminarians, the Knights of Columbus has committed to supporting our priests and religious communities.

From the RSVP forms:

The following persons are eligible to receive RSVP funds:

- Seminarians who have been accepted by a diocese and are currently in their "spirituality" year;
- Seminarians attending major seminaries (usually, four years) in preparation for priestly ordination;
- Seminarians in their "pastoral" year (most often, when they are deacons);
- Seminarians attending college seminaries (sometimes called minor seminaries);
- *Seminarians who belong to a religious institute and are currently in formation for the priesthood (religious seminarians often are called "Brother" even though they will eventually be ordained as priests); and*
- **Men and women who are novices or postulants in religious orders or religious communities**



Unlike Seminarians from a Diocese, these men and women usually are living under, normally, three Vows: **Poverty, Chastity, and Obedience**. By the time a Religious is in Seminary, he has already taken permanent vows to the Consecrated Life. Ordinarily, similar to the rules in our own Diocese for supporting our seminarians, an individual is not able to receive a gift directly, especially money, which would violate their Vow of Poverty. However, if a council coordinates with the Monastery, community or house, often the Prior or Prioress, a council can make a check out to the the individual in Care Of his or her Superior and it will pass Supreme scrutiny as well as provide for formation of that individual.

For a council to get credit and the reimbursement from Supreme, any RSVP funds HAVE to be written to benefit a specific individual. A check written to **Monastery of the Ascension** or the **Jesuits at BSU** or **Hermit Sisters of Mary** will NOT qualify even if you write it to the Vocations Director. Often, if you coordinate with the monastery, here's an example of how you may write your RSVP check:

- Sr. Mary Francis Jones, OSB
- c/o Mother Superior Mary Dominic Jones, OSB
- Benedictine Sisters Monastery
- address, city, zip

The funds have to be voted on and dispersed for a specific man or woman in formation. This can be found out by contacting the community. Links to Idaho communities are below. If you or your council officers have any questions, please feel free to contact me. There are added steps and sending a check without communicating with a community can prove counter-productive and may even



get sent back to your council! (We don't want to get our young men and women in trouble!).

Why Recruit?

The Order's tomorrow depends on recruitment today!

Guided by the principles of charity, unity and fraternity, the Knights of Columbus is committed to making certain that no person ever goes without food, shelter, warm clothing and financial security, and that aid is always available for widows and orphans in our local communities.

But the Order can't do this alone. It continually needs new members to help strengthen parishes and communities. And we must let qualifying Catholic men know that the Order needs them.

It's a two-way street. When we gain new members, we gain new brothers committed to Father McGivney's cause. And when new members join, they can strengthen their familial relationships, grow in their faith and gain exclusive access to top-quality insurance protection for themselves and for their family.



While some men in your parish know the Order very well, others know very little — like the participants in your parishes' RCIA classes. They are still learning what it really means to be Catholic and what it means to be a Catholic man in today's world. Welcome them to the parish, perhaps by offering Catholic Information Service materials to the entire RCIA class and letting them know they are welcome to contact your council if they have any questions. Then, after they have been brought into full communion with the Church at Easter, welcome them to join you at a Knights of Columbus event.

You should also reach out to the fathers of infants being baptized at your parish. With your pastor's permission, make it a practice of sending cards of congratulations to the parents of newly baptized children. With the card, send them a copy of a prayer card or a CIS booklet, such as *St. Benedict for Busy Parents* (#327). Later, you might offer words of encouragement about the importance of bringing their children to Mass every Sunday. Then, welcome them as a family to one of your council-sponsored family events. While there, you can ask the dad to fill out a *Prospect Card* (#921A).
